Statement of Satisfactory Behavior and Academic Performance

Condition of Enrollment As the parent/guardian of a student being enrolled under the tuition program, I understand that I must submit evidence of satisfactory behavior and academic performance as a condition of enrollment.

Enrollment is at the sole discretion of the Huda School & Montessori. Prior to enrollment, the following must be provided to meet the terms of satisfactory behavior and academic performance:

- a) Latest report card showing citizenship grade and current Grade Point Average (GPA).
- b) Latest Progress Report showing citizenship grade- if one exists. Citizenship must be passing, satisfactory, acceptable, or similar.
- c) Individual Educational Plan (IEP) and Progress Reports indicating progress toward goals and objectives- if one exists.
- d) 504 Plan- if one exists.
- e) **Conditions of Continued Enrollment** As the parent/guardian of a student being enrolled under the tuition program, I understand the tuition may be terminated if satisfactory behavior and academic performance are not maintained. Continued enrollment is at the sole discretion of Huda School & Montessori. The conditions of continued enrollment in Huda School & Montessori are outlined below:
 - f) Maintain a 2.0 GPA or above.
 - g) Maintain satisfactory behavior performance.
 - h) Any misleading, omitted, or incorrect information may be cause for immediate termination of enrollment.
 - i) In the event that the Huda School & Montessori determines that enrollment will be terminated, the parent/ guardian shall receive written notice of the termination.
 - j) Withdrawal from school: Parents choosing to pull their children out of Huda must provide written notice, their tuition must be paid up to date and a financial penalty paid before any records are released.
- k) **Parent/ Guardian Certification** By signing below, I the parent or legal guardian of the above named tuition student, certify that: a) My child meets the academic requirement of a minimum grade point average of 2.0, b) My child meets the behavioral requirement and any and all behavioral issue or concerns have been identified and discussed with enrollment staff and /or appropriate building administrators, and c) I understand the tuition enrollment may be terminated at the sole discretion of the Huda School Board if satisfactory behavior and academic performance are not maintained.
